

## Who Can Apply?

## The K.E.C.I.S.S is awarded to the following applicants:

- Students with a valid international passport (OCI/ PIO and NRI applicants are not eligible)
- Students who have continuity in their education, without any break or discontinuation
- Students who show excellent English proficiency, as all courses are taught through the medium

## What does the Scholarship cover?

The Scholarship helps to pay upto 50% of the tuition and on-campus accommodation fees (if applicable)

## St Kuriakose Elias Chavara International Student Scholarship (KECISS) Office of International Affairs

CHRIST (Deemed to be University) was born from the educational vision of St Kuriakose Elias Chavara, an educationist and social reformer of the 19th Century in South India (<a href="https://en.wikipedia.org/wiki/Kuriakose Elias Chavara">https://en.wikipedia.org/wiki/Kuriakose Elias Chavara</a>). He founded the first indigenous Catholic congregation in 1831, which administers CHRIST (Deemed to be University), Bangalore.

For the celebration of the 175th year of the establishment of the Sanskrit School in 1846 by St Chavara, which was a stepping stone towards universal and inclusive education for social transformation, CHRIST (Deemed to be University) institutes this scholarship for competent, global students, who need assistance.

The KECISS Scholarship is to enable non-Indian students to pursue their Undergraduate and Postgraduate studies at CHRIST (Deemed to be University) across campuses (Bengaluru, Lavasa and Ghaziabad). The Scholarship extends up to 50% of the total payable tuition fees and on-campus accommodation, to enable quality Global Higher Education opportunities.

#### Who Can Apply?

The **KECISS** is awarded to the following student categories:

- i. Students who have a valid international passport (foreign passport holders with OCI/PIO and NRI applicants are not eligible)
- ii. Students who have continuity in their education without any break or discontinuation
- iii. Students who have excellent proficiency in English, as all courses are taught through the English medium.

Applicants for the **KECISS programme** should have passed the Senior Secondary (10+2) or equivalent examination, or A Levels, or IB Board from a system of education recognized by the Association of Indian Universities (AIU).

#### Programmes offered under this Scholarship

This Scholarship Programme is offered to international students to pursue undergraduate and postgraduate courses in CHRIST (Deemed to be University) across all campuses, for both professional and non-professional disciplines in Engineering/Technology, Humanities, Social Sciences, Commerce, Management, Journalism, Hotel Management and LLB. #### Academic Eligibility Criteria:

- i. The candidate should have passed the Senior Secondary (10+2) or equivalent examination from a system of education recognised by the Association of Indian Universities (AIU), with requisite subjects.
- ii. The candidate should have secured a minimum of 80% aggregate marks or equivalent grades in the aggregate of all the subjects in the qualifying examination, or with a minimum of 2 A Levels in IGCSE /Cambridge Board, or a score of 32/42 in the IB Board Exams.
- **iii.** The candidate should have studied the prescribed essential subjects at the qualifying examination level.

Otherwise, the candidate should provide a certificate of equivalence from the Association of India Universities (AIU).

#### What is the procedure for applying to the KECISS Programme?

- i. Log into <u>www.christuniversity.in</u> and choose the course you are interested to join.
- ii. Complete the application process by paying the application fee.
- iii. Send the application number via email along with the application to <a href="mailto:isc.admission@christuniversity.in">isc.admission@christuniversity.in</a> and the relevant documents, including
- iv. Certificates and mark lists of 10+1 (mandatory), or 10+2 (if available), or O level and AS Level (mandatory), O Level and A Level (if available) or International Baccalaureate, and co-curricular activity certificates.
- v. A minimum of 01 letter of recommendation and a motivation letter (in not more than 1,000 words) before the given timeline.
- vi. An online interview will be scheduled to discuss the motivation, academic merit and other points of eligibility

#### What does the Scholarship cover?

The Scholarship is given upto 50% for the payment of tuition fees and for the on-campus accommodation fees.

The financial assistance is also extended in the second and the subsequent years, subject to excellence in academics, co-curricular activities and also the required percentage of attendance at the University.

#### When to apply?

You may submit the application on or before 30<sup>th</sup> May 2023.

Please note that only 20 Global applications will be selected for each academic year.
